Too many suppliers remain unmonitored and visibility into sub-tier supplier relationships is lacking, resulting in hidden risks that are only recognized once a disruption has happened.

Comprehensive visibility into your extended supply networks, down to the Nth tier supplier, enables procurement teams to proactively monitor and manage supplier and supply chain risk at scale. 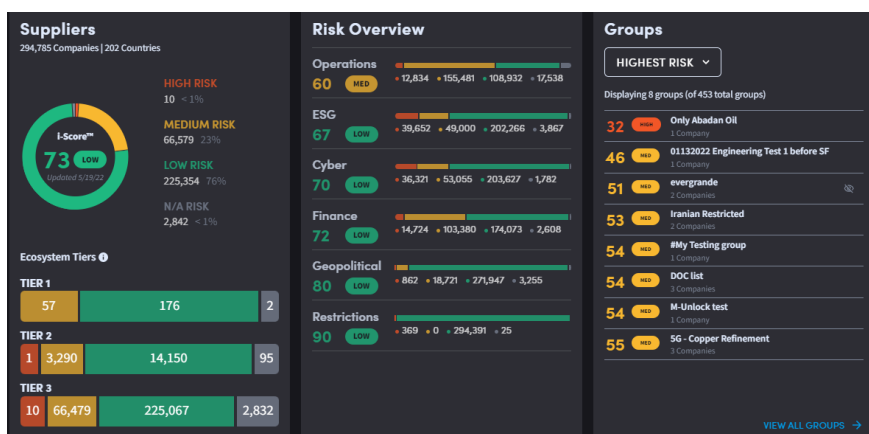


FIGURE 1. Interos monitors your extended supply chain across multiple risk factors for proactive risk management.
